# LETTER FROM OUR CEO



This annual report covers the time period October 2018 through September 2019. I had the good fortune to step in as JSA's Interim CEO in August of 2019. Ken White was JSA's CEO throughout the rest of the time period covered in this report.

Since 1934, the Junior State of America (JSA) has helped over 500,000 students acquire the knowledge and skills necessary to be active, informed and responsible citizens, voters and leaders. JSA enables students to experience first-hand the drama and power of politics as well as the challenges and responsibilities of leadership. JSA chapters serve as the center of political awareness at their schools and JSA conventions bring thousands of students together to share opinions and learn from each other. We are committed to developing a diverse cross section of young leaders throughout the entire country.

In 2018/2019 JSA ran programs in 33 states and the US Territories. JSA's school year programs were held in ten geographic regions, spanning across the US. In each region students plan and run three large overnight conventions, as well as countless smaller regional events. JSA's school year conventions reached from 300-1200 students, and included debates, thought talks, political fairs, and keynote speakers. In the time period of this report our students had the good fortune to hear from such political powerhouses as Senator Kirsten Gillibrand, Congresswoman Katie Porter, Congresswoman Katie Hill, James Comey, Legal scholar Adam Winkler, White House Press Secretary Sarah Huckabee Sanders, and Congressman Mark Takano.

In the summer of 2019 JSA ran a number of programs across the country. These programs included three-week summer schools at Georgetown, Stanford and Princeton University. In addition to these longer programs, one short Institute was held at UCLA, focused on Media and Politics, and another was hosted at Barnard University in New York, focused on Young Women's Leadership. JSA ran a small program in China focused on Chinese politics, history and language.

JSA has a long history, and its programs remain vital, timely, and critically important more than 85 years after the organization was founded. This annual report covers our revenue, summer school and institute impact, and school year programs. I hope it will provide you with a window into our work. JSA is at its core a non-profit organization focused on providing civics education programming to teens. We teach young people the value of democratic institutions. We help them to find their voice. We remind them that they are entitled to be heard. We provide them with a platform to engage with teens from all kinds of backgrounds, and from all parts of the country. I am proud of the work JSA does and continues to do. I think after you read this report, you will be proud too.

# 387 Chapters Make Up 10 "States"

JSA is divided into 10 states, each led by an elected Governor and appointed Cabinet members. Chapters collectively form regions within the states and are responsible for planning and executing events and activities that include educational conferences and national activism initiatives.



These states (Arizona Territory, Pacific Northwest, Northern California, Southern California, Texas, Mid-Atlantic, Northeast, Midwest, Ohio River Valley, and the Southeast Territory) are separate entities with separate governments. Each state or territory has its own constitution that broadly outlines its governing protocol. The vast majority of power lies with the individual states and territories.






# **About Fall State**




# **About Winter Congress**






# **About Spring State**


# About Young Women's Leadership Institute


# About the Burd Institute on Media & Politics


# **About the Program**


# **About the Program**




# **About the Program**

# **Summer Scholarship Awards**




